**CREDIT TERMS**

North Creek initially offers credit terms of net 30 days from the date of the invoice. Any balance unpaid beyond 30 days of the date of the invoice is considered past due. A service charge of 2% per month (24% annually) will accrue on any balance that is past due. Said service charge will commence on the 31<sup>st</sup> day past the invoice date.

All credit terms shall be suspended on any account past due for 60 days or more.

No claim will be allowed for damages, shortages or errors unless reported within 5 business days of receipt of goods. Any returned material will be subject to a 20% handling charge.

NOTE: Applicant's signature is required before North Creek will agree to sell on credit terms. By signing, Applicant agrees to be bound by the terms and conditions contained herein. Applicant agrees to pay entire balance net 30 days. If Applicant fails to pay entire balance within the net 30-day period, Applicant hereby agrees to pay the service charge of 2% per month on any outstanding balance commencing on the 31<sup>st</sup> day.

Should it become necessary for North Creek to file suit, or hire an outside collection agency to obtain payment hereunder, Applicant agrees to pay all costs associated therewith, including but not limited to court costs, attorney's fees, costs of service, etc.

It is hereby agreed that any action to enforce payment shall fall under the jurisdiction of Chester County, Pennsylvania.

North Creek hereby reserves the right to suspend or terminate Applicant's credit terms at any time for any reason or no reason at all.
